1a. Mission Statement

The Lighthouse Christian Academy's mission is to see lives transformed by God and for God. We do this by following the Biblical Hebrew tradition to disciple young men and women to follow in the way established by the word of God, as exemplified in the life of Jesus Christ. Graduates of this church ministry will be equipped to defend their faith and live a lifestyle exemplary in its imitation of true Biblical morality. The Lighthouse Christian Academy trains young men and women to develop godly character through the cleansing power of the word of God. This Christ-centered environment promotes the development of a sincere relationship with God the Father through Jesus Christ and the indwelling of the Holy Spirit to transform the heart and mind.

We believe that men and women of character will be equipped to work wholeheartedly at whatever task they are required to complete. This strong emphasis on character development enables the Lighthouse Christian Academy to educate its students successfully with an academically rigorous college preparatory curriculum.

1b. Statement of Purpose and Theology

The Lighthouse Christian Academy (LCA) is a non-profit Christian high school operated as a ministry of the Lighthouse Church.

The LCA serves students who indicate their desire to succeed in a truly Christian environment with a rigorous academic curriculum. Following a liberal arts tradition, the curriculum aims at preparing each student for admission to a four-year university while also providing co-educational opportunities for students interested in careers outside the traditional four-year path.

The LCA's curriculum emphasizes the need of person to have a personal relationship with Jesus Christ by focusing on Judeo-Christian values and teaching. The message of salvation and redemption through Christ alone permeates discussions in every academic discipline. Students are encouraged to devote themselves to a life of serving God through obedience to His Word and by the guidance of the Holy Spirit. The LCA emphasizes effective oral and written communication, study skills, critical and interpretive thinking, and the ability to make Godly, rational, and informed judgments by adhering to Biblical tenets when making decisions.

In an attempt to assist students in becoming functioning members of the body of Christ, the LCA provides specific religious instruction that is true to the doctrines of the International Church of the Foursquare Gospel and Christian Fellowship Ministries. The Academy strives to impart the vision of discipleship, world evangelism and church planting into all of its students, and to nurture the spiritual development of the young Christian and non-believer. Students are taught to understand that individuals are justified by the grace of God the Father, through faith in the atoning sacrifice made by Jesus Christ. They are encouraged to come to Christ as sinners, but to be transformed and turn from their life of sin and become Saints by the power of the Holy Spirit.

The LCA recognizes that, as indicated in the Bible, parents are the primary educators of their children. Therefore, the LCA expects the full cooperation of parents/guardians in their children's education. It is our hope that the guidance and discipline they receive through the various academic disciplines and extracurricular activities offered at the LCA will help to solidify the foundation of Biblical teaching the children have received at home.

1c. History

The Lighthouse Christian Academy (LCA) is a small co-educational, college preparatory, non-profit Christian high school located in Santa Monica, CA. It is a continuation of the Lighthouse Christian School, which serves grades K-8. Both schools are ministries of the Santa Monica Foursquare Church located at 1220 20th Street. The LCA was founded in 1983 by members of the Lighthouse Church, who were driven by the desire to see their children educated in a truly Christian environment with a strong academic curriculum and the highest moral standards.

In 1983, the leadership and parents of the Santa Monica Foursquare Church established the LCA as an alternative form of education. Their goal was to provide Christian education for the children of church members. Parents in the congregation wanted an educational system that reflected the values that were promoted in their homes and church. Initially, the classes were held in the church building. Overtime the LCA went from being exclusively a church-based homeschool to being a private Christian school open to the broader community.

In 2004, the Santa Monica Foursquare Church purchased the current school property at 1424 Yale Street from the Missionary Alliance Church. The purchase of the property was approved by the congregation with the unanimous desire to not lose a single existing church to the development of commercial ventures in Santa Monica. The purchase of this property gave the LCA its own campus. From 2005 through 2012 the school has undergone numerous site repairs and enhancements to meet and conform national accreditation standards and Santa Monica municipal code requirements for schools.

In July 2007, the LCA received full accreditation from the International Christian Accrediting Association (ICAA) and in February 2011, the LCA received accreditation from AdvancED under the taxonomy of the North Central Association on Accreditation and School Improvement (NCA CASI).

In recent years the LCA begun enrolling foreign exchange students. LCA has received students from China, Germany, Japan, Italy, Spain Finland, Thailand and Brazil. The LCA also began offering a PACE Learning System program that utilizes individualized lessons combined with personalized instruction to meet the needs of course acceleration, credit recovery, and alternative classroom environments.

In its nearly two decades of existence the LCA's athletic programs have multiple post-season successes including twice winning the CIF Championship in Girls' Volleyball and twice coming

in Runner-Up in the CIF 8-man Football Championship. Some of our athletes have been recruited to play on D-I NCAA sports teams.

LCA graduates have also gone on to top-tier colleges and universities including UCLA, USC, and Harvard and Stanford graduate schools. Our alumni fill the spectrum of professions and career fields including lawyers, doctors, dentists, pastors, teachers, writers, and filmmakers.

1d. Accreditation

Lighthouse Christian Academy received accreditation in 2007.

LCA is currently accredited by two agencies:

1e. Crest

The school's motto, "Ardens sed Virens", is Latin for "burning but still alive." It is a reference to the Burning Bush which was burned but not consumed. The school was given this motto to exhort the students to live by the fire of the Holy Spirit. It is a picture of an inspired life sustained by supernatural power in its devotion to Christ, passion for life, and dominion of God.

The Lighthouse on top of the crest is the symbol of the Lighthouse church which oversee all of the school ministries.

The **Cross** represents devotion to Jesus Christ and his sacrificial death and resurrection by which all mankind was made free.

The **Bible** represents devotion to God's Word as the foundation of wisdom and knowledge of God's plan for our lives.

The **Flag** represents devotion to the United States as a nation founded upon the principles of God's Word and his sovereignty over all nations and the affairs of man.

The **Cup** represents a devotion to excellence and the desire to be outstanding for the Glory of God in all arenas of life.

1f. Mascot

Spirit week is a time at Lighthouse Christian Academy where students are encouraged to dress wacky and participate in zany and hilarious activities. Many students take advantage of spirit week to show off who can get the craziest.

One year, seniors Luke Peterson and Adam Ayala were devising a plan to top all Lighthouse spirit weeks in the past years. Their idea was to get a full body costume, rather than just dressing in tacky clothes. One costume really stuck out to Luke, and that costume was the St. Bernard. He thought it would be a great idea, not only for spirit week, but also as a mascot that would put a

face to the Lighthouse “Saints”. After spirit week was over, Adam donated the costume and gave the LCA Saints its first mascot, St. Bernard.

In spite of its ad hoc origin, there is a clear connection between the “Saints” and our mascot. St. Bernards became famous for saving lives in the early 18th century. Monks living in the dangerous, snowy St. Bernard Pass- a route through the Alps between Italy and Switzerland- kept the canines to help them on their rescue missions after bad snowstorms. These dogs would find travelers buried in deep snow and dig them out, afterward lying on top of them to provide warmth. St. Bernards soon came to be seen as animals of mercy and salvation.

The actual word “Saint” though means “holy” or “set apart.” It is used many times in the Bible, referring to the followers of Jesus Christ – who is the ultimate symbol of mercy and salvation. Jesus performed miracles; many times having brought people back from the dead and curing deadly illnesses.

After the initial founding of the Lighthouse Christian Academy, teachers and students chose to call themselves the Saints because their mission statement calls on to be set apart from the world as followers of Christ or “Saints”. After the football and volleyball teams were created, it was only natural to put a name to the face of Lighthouse sports teams. The church held a contest in order to choose the best name, and the name “Saints” won.

Jesus states in Matthew 28:19, “Therefore go and make disciples of all nations...” Saint Bernard is simply a fun reminder that this call is a mission of love to rescue the sick and dying in our world and bring them to the One who can save them.

1g. Values

The Lighthouse Christian Academy has five core values:

- Education*. Continual life-long learning is important because knowledge is power. We emphasize this as college-preparatory, liberal arts high school, that is dually accredited.
- Christian*. Christian Character is essential life transformation and growth.
- Take responsibility (no excuses)*. The outcome of your life is determined by the choices that you make. You are not a victim.
- Consider others (everyone)*. You are not alone and your actions affect others. We try to live by the golden rule: treat others the way you want to be treated.
- Love*. Love is the most excellent way. You can love well once you realize how much you are loved.

These values together create the acronym EXCEL. The Lighthouse Christian Academy is a school to help you EXCEL. To EXCEL is not to compete with others, rather it is the process of becoming a better you. We at LCA want you to be successful!

2a. Statement of Philosophy of Christian Education

“Train up a child in the way he should go and when he is old he shall not depart from it.”

It is the aim of the Lighthouse Christian Academy to prepare each student for admission to a four-year university. We do so by emphasizing the need of every person to have a personal relationship with Jesus Christ by focusing on the Judeo-Christian values and teachings upon which our country was founded.

The message of salvation and redemption through Christ alone permeates discussions in every academic discipline, for it is this message that inflames hearts and minds to reach their fullest academic and moral potential.

The LCA attempts to assist students in becoming functioning members of the body of Christ by providing strong examples in our teachers and staff and partnering with families in their student's education. It is the weaving together of this community network of teachers, students, and parents under the authority and grace of Jesus Christ that enables each party to reap the greatest benefits of education, namely to think, judge, and act in accordance with the teachings of Jesus Christ our Lord.

2b. Statement of Faith

WE BELIEVE the Bible to be the inspired, the only infallible, authoritative word of God.

WE BELIEVE that there is one God, eternally existent in three persons: Father, Son and Holy Spirit.

WE BELIEVE in the deity of our Lord Jesus Christ, in His virgin birth, in His sinless life, in His miracles, in His vicarious and atoning death through His shed blood, in His bodily resurrection, in His ascension to the right hand of the Father, and in His personal return in power and glory.

WE BELIEVE that for salvation of lost and sinful men, regeneration by the Holy Spirit is absolutely necessary.

WE BELIEVE in the present ministry of the Holy Spirit by whose indwelling the Christian is enabled to live a godly and miracle-filled life.

WE BELIEVE in the resurrection of both the saved and the lost; they that are saved unto the resurrection of life and they that are lost unto the resurrection of damnation.

WE BELIEVE that heaven and hell are definite places.

WE BELIEVE in the spiritual unity of believers in our Lord Jesus Christ.

3. Statement of Non-Discrimination

The Lighthouse Christian Academy admits students of any race, color, creed, national and ethnic origin to all the rights, privileges, programs, and activities generally accorded or made available to students at the school. It does not discriminate on the basis of race, color, creed, national or ethnic origin in administration of its educational policies, admissions policies, scholarships, loan programs, athletic programs and other school administered programs.

4a. Bible Class and Church Participation

Because the Lighthouse Christian Academy is a ministry of the Lighthouse Church, Bible teaching is an integral part of campus life. Students must take a minimum of 5 Bible units per semester with a total of 40 units required for graduation. Throughout the semester students may be asked to participate in various Lighthouse Church activities as part of the Bible class.

4b. Academy Trips, Evangelism, and Activities

Students often build and strengthen their relationships with Jesus Christ through fellowship with other students, teachers and chaperones outside of the traditional educational experience. Experiences outside the four walls of the classroom build strong ties between teachers and students that facilitate the impartation of wisdom and knowledge in the classroom setting. As a result, events organized by the Lighthouse Christian Academy are an integral part of the curriculum and may be a required component of a student's Bible or elective class. These events may include local outreach, international evangelism, trips to Bible conferences, men's rallies and women's retreats, school ski trips, rafting excursions or other camping related adventures, fellowship at sporting events, and other extra-curricular activities. We strongly encourage students to strengthen their relationship with Christ by becoming involved in the greater school and church community. Classes may be canceled during school trips and students who do not participate may be marked absent.

5a. Admission Procedures

THE FOLLOWING ITEMS ARE DUE AT REGISTRATION

1. Registration form
2. **Non-refundable** registration fee (first time enrolling students only)
3. Credit/Debit Card Payment Authorization form
4. Signed Authorization to Release School Records
5. Current health records, including Pre-participation Physical Examination form, Physical Examination form and Immunization Record
6. Sports Permission form
7. Copy of Birth Certificate
8. Parent-Student Handbook signature page

A complete registration packet can be downloaded from the admissions page on our website.

After submitting the complete registration packet, the new student and a parent need to schedule an interview with the principal.

By admitting the student into Lighthouse Christian Academy, the student's parents give Lighthouse Christian Academy the right to use the student's photograph for reproduction in any medium for the purposes of publication, advertising, display, or editorial use. No personal information will be publicized.

5b. Withdrawal/Dismissal/Graduation Procedures

The school reserves the right to refuse continued enrollment or re-enrollment to students or families for reasons including substantial violations of the school's handbook, moral standards, spiritual standards, lack of payment, defaming the reputation of the school, or lack of cooperation with the staff. Such situations are determined at the sole discretion of the school leadership.

The official release of transcripts must be requested in writing. **Transcripts and other records will not be released until all outstanding tuition and fees have been paid and the student's account is current.**

Students who withdraw from school before the conclusion of any semester will be issued check out grades. No partial credits are awarded.

If a student drops a class during **Week Two** of the semester, there will be no penalty. If a student drops a class during **Week Three** of the semester, he/she will receive a Withdraw (W) on his/her

transcript. If a student drops a class **after Week Three** of the semester, he/she will receive a Fail (F) on his/her transcript. The withdrawal form must be signed by the parent(s), teacher, guidance counselor, and Head of School before the course is officially dropped. The student is to remain in attendance in the class until notified by the office that the withdrawal is completed.

5c. Gradelink

Student assignments, grades, missing work, correct contact information, announcements and other critical information is available online via Gradelink. Once the student has been registered, an account will be enabled. The username and password will be generated for you. You can access Gradelink by downloading the app to your phone or online by going to www.gradelink.com. Our school code is 727. Contact the school office if you need help accessing your account. Parents and students should check their account for student and school events at least weekly.

6a. Attendance Policies and Procedures

Regular school attendance is essential to successful academic growth, and the fellowship of students in the classroom and participation in class and activities are irreplaceable components of the learning process. The continuity of the learning process is disrupted by absences, excused or unexcused.

Students who are absent will need to verify student absence by a signed note from parent/guardian. The note must include the date(s) and specific reason(s) for the absence. Students who arrive late without a legitimate excuse will be marked tardy or may be marked absent and not allowed in class. While students will be marked absent/tardy for recording purposes, they will be allowed to make up all missed work.

Absence: A student is absent when he/she is not present during a scheduled class period. Students will also be marked absent if they miss more than half a class period due to late arrival. Students without a signed note from a parent/guardian may not be allowed to make up missed assignments. See individual class syllabi for details.

Tardy: A student is tardy if he/she is not in his/her correct seat and prepared to begin class when it starts. Every three tardies are equal to one absence.

Required Course Hours: Students absent - excused or unexcused - for more than 12 school days/classes (or 12% of required course hours) in one semester will receive a grade of INCOMPLETE. If class hours are not made up by the end of the following summer session, they will receive a failing grade.

Family vacations and personal holidays are discouraged during regular school days. Parents are encouraged to plan vacations based on the school calendar. ***If a family holiday is taken during regular school days, any missed work and/or tests may not be made up until after the student returns to school.*** Teachers are not required to provide make-up work prior to a family's vacation or holiday. Students may not make up missed work or tests after a grading period ends. ***Absences will be unexcused for this type of leave by a student.***

Cutting Class

Any student who intentionally "cuts" a class or series of classes will receive an unexcused absence for each class affected and will be required to make up the time missed from school in detention. The student will not receive credit for any missed homework and/or test(s). If a number of classes are missed, the Principal may assign the student in-school suspension instead of detention.

Unexcused absences during the grading period will result in the student receiving no credit for work due during the absence and not being permitted to make up any tests that have been missed. Students receiving in-school or at-home suspension will receive no credit for homework due the day of the suspension and no credit for tests given the day of the suspension.

6b. Test and Homework Make-up Policy

In accordance with our value of taking responsibility we have a strict **NO LATE WORK** policy. Teachers have discretion when allowing students to make up tests or homework missed during excused absences. Most any absence can be excused with a note to the school by parent/guardian. Truant behaviors, such as late or absent from break periods, are NOT excused absences.

It is the **student/parents'** responsibility to obtain the necessary information to make up any missed tests, homework, or assignments.

Students who know in advance that they will be absent from school should obtain their assignments before their absence, so that they may complete them and turn them in on the day of their return to school.

7a. Core School Day

The core school day begins at 9:00 A.M. and ends at 2:00 P.M. Monday through Friday. Each semester includes Bible class and two block class periods. During these periods all students take their core subjects of mathematics, literature, science, and history.

An elective period is available from 2:15-3:30 PM. Students will be placed into a elective class based upon their grade level, however parents can opt out of most elective classes, as long as a replacement elective is chosen for the semester.

Try to make arrangements with your child prior to coming to school. If plans change and you must contact your child, call the school office before 12pm and a message will be given to the child's teacher. After 12pm, the activity level in the office may prevent a message from reaching your child. If your child forgot something and it is impossible for the student to go without it such as a lunch, books, or PE clothes, bring the items to the school office for delivery to the student.

You may leave messages with the office which will be delivered at the end of their instruction time. Messages to students during class time are disruptive. If it is absolutely necessary to reach your student before the end of the period, let the office know when you leave the message. ***Do NOT call your student's cell phone during class time.***

Students needing to visit the school office should arrange to come in before school, at break, at lunch, or after school. Students will not be allowed in the office at other times without a pass. The school office is a place of business for school staff, parents and the public and should be treated as such.

Parents should make every effort to schedule doctor, dentist, or other appointments for their students after the final core period at 2 pm so as to avoid students missing core class periods.

7b. Elective Classes

Elective classes are held outside of the core school day. Depending on the classes students are taking or that they choose, they may have class anywhere from one (1) to five (5) days a week at varying times and locations. Classes are chosen before the start of each semester and can be dropped or added up through Week 2. Students must take 10 elective units per semester. Only 5 of the elective units may be from a P.E. elective. Contact the school office for an up-to-date catalog of Bible and elective classes.

7c. Pick-Up/Drop-Off

All cars carrying Lighthouse Christian Academy students must travel from west to east through the alley. This means pulling into the alley from Harvard Street and out of the alley onto Yale Street – no exceptions.

Cars must pull up along the north side of the staff parking lot and then stop to let students out in the designated drop-off/pick-up area. When pulling up to the drop-off/pick-up area, cars should stay as far to the right of the alley as possible in order to allow cars traveling in the opposite direction to pass through unhindered.

Students must exit their cars in the designated drop-off/pick-up area only, from the right side of the vehicle. They should be ready to exit as quickly as possible to keep traffic flowing smoothly.

After leaving the designated drop-off/pick-up area, cars must make a **right turn only from the alley onto Yale Street.** Visibility from the alley is poor and making a left turn onto Yale Street is considered unsafe.

A member of the LCA staff will be assigned to supervise drop-off and pick-up each morning. Parents and students must obey all instructions from the traffic monitor.

A \$50 fine may be charged to anyone who violates the drop-off/pick-up policy.

7d. Access to the School Building

For security purposes the LCA school building will remain locked at all times during the school day except during the 5-min passing period after Bible, the 15-min morning break, and the 40-min lunch period. A video/door bell system will provide supervised access to the building from 9am until closing (approximately 4:30pm). Students, parents, and visitors will be buzzed in by the office upon arrival.

Students returning late from breaks after the door has been shut will have to buzz for reentry. Tardy students will receive 2 warnings each semester. After the third infraction, violating students will receive a 1-day suspension on the day following the third tardy.

Any students who tamper with the reentry procedures will receive at least a 1-day suspension.

7e. Student Parking

Students are discouraged from driving to school and only limited student parking spaces are available. To park on campus a Conditional Student Parking Permit must be issued. All students who wish to obtain a Conditional Student Parking Permit will be required to 1) sign a statement

of compliance regarding the conditions of the permit and 2) provide copies of his/her driver's license and car insurance. The permit will be revoked immediately if the student violates any of these conditions.

The school reserves the two tandem parking spots on the east end of the parking lot for student permit parking. Those spots are available to permit parking each day on a first come, first serve basis. All other parking spaces are reserved for teachers, staff, and visitors.

A \$50 fine may be charged to any student who drives to school without a Conditional Student Parking permit.

7f. School Property/Student Supervision

The Lighthouse Christian Academy attempts to allow students full use of its facilities whenever possible but does not have sufficient staff on campus to closely monitor the activities of students after school hours. As a result, students will not be supervised by LCA personnel after the official end of the core school day at 1:30 P.M. unless they are involved in a school-sponsored elective or activity.

The property and facilities of LCA have been provided through the dedication and giving of many people. Students are encouraged to respect all school property and to take pride in the appearance of their school. Students are encouraged to properly dispose of their own litter as well as that left by others.

Students who damage, deface, tamper with, or destroy in any way, school property will be compelled to pay for the damages and may be subject to further disciplinary actions.

7g. Delinquent items

The LCA aims to keep its facility clean and to teach students personal responsibility for their personal items. Student personal items left lying around campus after hours will be placed in a Lost and Found in the School Office. **Students may reclaim their lost item for \$1 each. Items not claimed after one month may be donated to a thrift store.**

8a. Textbooks

Students are responsible for purchasing all textbooks themselves. Book lists for online purchasing will be available by LCA at least 2 weeks prior to the start of classes. **Students are expected to have all textbooks by the first day of each semester.** Students may also be required to purchase additional reading materials (novels for English classes, etc.) individually throughout the year. In the event that a student loses or damages a book, he/she will be responsible to replace them by the next week.

At the end of the year students are welcome to resell any of their textbooks to other incoming students or textbook dealers or to donate them to the school.

8b. Computer Lab

The computers are utilized for varying purposes during specific class periods and may be open for student use during lunch and study hall periods depending on available supervision. The computer lab is available for student use only for necessary school or personal needs and when supervised. Students who use any computers inappropriately will be disciplined. Utilization of the Internet inappropriately will result in suspension with the possibility of expulsion.

BEHAVIOR POLICIES AND GENERAL EXPECTATIONS

9a. Student Conduct

In order to create an environment that exemplifies the attributes of Biblical love in which young men and women can be free to achieve their spiritual, academic, and athletic potential, it is necessary to maintain a disciplinary system that strives to develop godly character, not just good behavior. The character of an individual is what God knows to be true about that person; it is not the outward appearance of righteousness as seen by man. Lighthouse students are expected to live righteous and moral lives before, during, and after school. Therefore, any student involved in immoral or unrighteous behavior that violates conduct guidelines at any time while enrolled in the Lighthouse Christian Academy will be disciplined.

Conduct guidelines are designed to keep students from sinning against God, causing their brethren to stumble, and succumbing to the temptations of our society that lead to sin. Students who willfully choose to disregard these guidelines will be held responsible for their actions. The LCA has instituted high standards of morality for its students in accordance with Scripture. These Biblical standards have been adopted in order to train children in the way they should go (Proverbs 22:26). Discipline is not pleasant at the time of its administration, but it provides the opportunity for students to humbly accept the consequences of their actions. This process helps establish submission to authority, and to instill humility and the ability to repent from wrongful actions and motives. Parental involvement at all stages of the discipline process is also essential.

The LCA does not want students to be disobedient and rebellious, but it recognizes every conduct infraction as an opportunity for change in the character of the student being corrected. Through the process of discipline, maturity and Christian character are developed.

9b. Conduct At School Activities

School-sponsored activities (athletic contests, field trips, etc.), whether at school or off-campus and regardless of time, are under the jurisdiction of the LCA. Those attending such functions, or in the immediate proximity, will be expected to follow school regulations governing proper conduct. Violations of school regulations at school-sponsored events will result in disciplinary action.

9c. Dress and Grooming Code

The Lighthouse Christian Academy expects student attire to be worn in an attitude of love, meaning it projects a positive image of the school that is uniform, polite, and humble. The dress and grooming code is designed to eliminate students' ability to set themselves apart from other classmates strictly by their appearance and focus instead on forming inner character and identity. The dress code is casual. It reflects the weather and style of Southern California and places an emphasis on comfort, practicality, modesty, and neatness. The dress code takes effect any time students are on campus during regular school day hours, including students from the time they step onto campus in the morning until they leave campus at the end of the day. This includes before and after school.

General Expectations

Must be neat and clean, properly fitted, and not torn or missing buttons. Hoods or hats may not be worn in class, and sunglasses may only be worn outside. Haircuts and hairstyles must be in good taste and reflect a student's natural hair color. Hair cannot be cut or styles in an outstanding way. Tattoos and body piercings are prohibited.

BOYS

<u>Hair</u>	Cut above the eyebrows in the front, above the ears on the sides, and off the collar in the back. Braiding, ponytails, dyeing, and bleaching are prohibited. Facial hair should not be distracting or unkempt.
<u>Pants</u>	Navy blue or tan (khaki) trousers/dockers. No jeans or corduroys. A belt must be worn at all times.
<u>Shirt</u>	Soft-collared navy blue, white, or yellow polo shirt or white, button-down dress shirt (short or long sleeved). White undershirts without a noticeable print may be worn under uniform shirts. Shirts must be tucked in.
<u>Shoes</u>	Close-toed shoes or sneakers of subdued colors must be worn at all times. Shoes should not be distracting: no shoes with images or writing or colored laces. Sandals are not permitted.
<u>Outerwear</u>	Sweatshirts must either be the LIGHTHOUSE sweatshirt or the SAINTS hoodie. NO OTHERS will be acceptable in the school building. Raincoats and overcoats will be allowed to be worn until entrance into the school building, but cannot contain any distasteful images.
<u>Accessories</u>	Boys must wear a belt at all times. Boys may not wear any jewelry at any school activity with the exception of a promise ring (which signifies their dedication to remain sexually pure until marriage.) Make-up and nail polish are prohibited.

GIRLS

Hair	Dyeing (other than natural color) and bleaching (other than natural looking highlights) are prohibited.
Pants	Navy blue or tan (khaki) trousers/dockers. No jeans, jeggings or corduroys. No low-rider or skinny styled pants or pants with stretch material may be worn. A belt must be worn at all times.
Skirt	LCA plaid, khaki, or navy. Must reach no higher than the bottom of the students fully extended fingertips
Shirt	Soft-collared navy blue or white polo, or white, button-down blouse (short or long sleeved). Blouses must be worn with every button except the top one buttoned. Blouses and shirts must be tucked in. White undershirts without a noticeable print may be worn under uniform shirts.
Shoes	Close-toed shoes, sneakers, or boots of subdued colors and style must be worn at all times. Shoes should not be distracting: no shoes with images or writing or colored laces. Sandals are not permitted.
Outerwear	Sweatshirts must either be the LIGHTHOUSE sweatshirt or the SAINTS hoodie. NO OTHERS will be acceptable in the school building. Raincoats and overcoats will be allowed to be worn until entrance into the school building, but cannot contain any distasteful images.
Accessories	Girls may wear one earring in each ear, one ring on each hand, one bracelet on each arm, and one necklace. Only make-up that is natural in color and accents the natural features may be worn. Only black, navy blue or white socks, hose (no fishnet, or other racy styles will be permitted), tights, or leggings may be worn under the school skirt.

Athletic & Game Day Attire

After school, students may change into appropriate athletic attire for participation in Lighthouse sports teams or Physical Education classes. If authorized by the coach of a Lighthouse team, students may wear athletic jerseys to school on game day on top of their polo.

Rainy Day Attire

On rainy days students can wear any color / style water-resistant outerwear while they are outside, so long as it is not offensive in nature. When they come into the classrooms, students are to remove the outerwear and be in uniform while inside the classes.

Violations

Students wearing non-uniform items to school will have those items confiscated. Confiscated items can be redeemed at the end of the school day for \$1.00

Students with uniform violations will be disciplined as follows:

First Offense: Warning

Second Offense: 1 pg. discipline essay (given absence in classes)

Subsequent Offenses: 3 pg. discipline essay (Sent Home - given absence in classes)

9d. Elective Dress

For Elective classes students take off-campus and outside regular school hours the standard uniform is not required. Instead students should dress in a manner appropriate to their class as prescribed by their instructor. Outside of teacher direction, the overriding criteria is that attire and grooming should be polite and humble.

Students who do not dress appropriately for their Elective Classes will not be able to participate in their class and may receive lower marks for that class.

9e. Technology Code of Conduct

Lighthouse Christian Academy fully understands the importance of computer technology to the educational process and has incorporated technology into its curriculum. Technological resources are to be used according to LCA's mission and Christian philosophy of education. LCA is committed to embracing technology to enhance learning and to the responsible use of electronic devices and computers. The standards of use and consequences for misuse are outlined below.

Students may use their cell phones outside of the school building during breaks, and lunch for communication purposes only. Non-school related electronic communication (e-mail, social networking, electronic chatting, instant messaging, text messaging or video chatting) is prohibited. During any other times, including class time, office hours, labs, school events, or chapel, cell phones must be turned off and be out of view. In case of an emergency and during non-designated use times, incoming and outgoing cell phone calls/texts can be made with permission in the office.

During the school day *iPads and laptops* may be used for academic purposes only. Non-school related electronic communication (e-mail, social networking, electronic chatting, instant messaging, text messaging or video chatting) is prohibited. Laptops, iPads or similar devices may not be used to play music unless given express permission by the teacher.

At no time is a student to use a computer, iPad, cell phone or other electronic device to watch non-school related videos or play games.

At no time is a student to use a computer, iPad, cell phone or other electronic device to access pornography, illegal activity or for the purpose of gambling.

At no time is a student to make any attempt to circumvent the school's computer security settings or to visit blocked sites. Students who attempt to circumvent the school's security settings will be suspended from school and recommended for expulsion.

At no time is a student to use technology in ways that violate school-wide behavior standards (i.e. plagiarism).

At no time is a student to download applications onto a school owned computer.

At no time is a student to use the network/technology for financial or commercial gain.

At no time is a student to degrade or disrupt equipment or system performance.

At no time is a student to invade the privacy of other individuals by accessing and/or vandalizing their computerized data.

At no time is the student to utilize technology for unauthorized aid during an exam or quiz. Such activity will be a violation of both the honor code and the technology policy.

At no time is a student to record a teacher or another student in class without prior permission. Students who are given permission to record may not post recordings on any site. Recordings are for academic purposes only.

Students must not attempt to download or stream unauthorized copyrighted material. Students must not install or use “peer-to-peer” file sharing software or services.

Students may not use technology, on or off campus, to harass, bully, socially alienate, intimidate or tease other students, teachers or administrators.

Cyber-bullying is done by sending messages, pictures, or information using electronic media, computers (email, instant messages, social networking sites), or cell phones (text messaging and voicemail). It may include writing comments about a person on a website, via instant messaging, or through text messaging, posting pictures or videos of others without their permission, or tormenting, threatening, taunting, degrading, targeting, harassing, or humiliating a student or staff member using the internet, interactive and digital technologies, or mobile phones or inviting others to join in these acts. Students who engage in cyber-bullying, on or off campus, will face disciplinary action.

Technology needs to be utilized with the importance of social interaction and courtesy in mind. Students who utilize technology in a discourteous way or who disrupt social interaction will be asked to refrain from using technology on campus.

Current students and school staff may not be “friends” on social media sites.

Students:

- Are responsible for their own device(s).
- May not leave devices unattended. All electronic devices must remain in the student possession or locked in the student’s locker.
- May not lend their device to others. If a student lends a device to a peer and the device is misplaced, the student who owns the device will be held responsible.
- May not steal or borrow devices from others. Students who are caught stealing will be automatically suspended and will be recommended for expulsion.
- Who damage school computers/devices or student computer/devices are responsible for the

replacement cost of the device.

Inappropriate use of any electronic device will result in the item being turned into the school office for five days. In the case that a cell phone rings or vibrates by mistake because the student forgets to turn it off, the phone will be turned into the office until the end of the school day. Repeated violations of the technology policy will result in the loss of all device privileges and further disciplinary actions.

The school reserves the right to regulate, review, investigate and discipline students for cyber-bullying, harassment, violation of the honor code, violation of the technology policy or for other disciplinary violations when such Internet statement, postings, or acts are made while on school campus, or while made off-campus and such statements, postings, or acts threaten violence against another student/staff member, or otherwise disrupt the learning environment or orderly conduct of the school, school business, or school activities.

If an agent of the school becomes aware of possible alcohol, and/or drug use, or other inappropriate behavior through Internet postings, we will share this information with the parents and the appropriate authorities and reserve the right to take disciplinary action whenever proper.

9f. Sexual Harassment and Bullying

Sexual harassment or bullying of students is an extremely serious violation of the Code of Student Conduct, as well as a violation of criminal law. **It will not be tolerated at all, but especially in schools, school vehicles, or at school-sponsored activities. Any such offenses will result in severe disciplinary action.**

Employee-student, student–student, and employee- employee sexual harassment are all prohibited.

What To Do About Sexual Harassment:

1. Students who feel that they have been subjected to conduct of a harassing nature are encouraged to promptly report the matter to one of the school’s officials.
2. Students who observe conduct of a sexually harassing nature are also encouraged to report the matter to one of the school’s officials.
3. All complaints will be promptly investigated.

Examples of bullying:

1. **Physical bullying** includes any physical contact that would hurt or injure a person like hitting, kicking, punching, etc. Taking something that belongs to someone else and destroying it would also be considered a type of physical bullying.
2. **Verbal bullying** is name-calling, making offensive remarks, or joking about a person's religion, gender, sexual orientation, ethnicity, socioeconomic status, or the way they look. Verbal aggression is when a bully teases someone. It can also include a bully making verbal threats of violence or aggression against someone's personal property.
3. **Indirect bullying** includes spreading rumors or stories about someone, telling others about something that was told in private, and excluding others from groups.
4. **Social alienation** is when a bully excludes someone from a group on purpose. It also includes a bully spreading rumors, and also making fun of someone by pointing out their differences.
5. **Intimidation** is when a bully threatens someone else and frightens that person enough to make him or her do what the bully wants.
6. **Cyber bullying** is done by sending messages, pictures, or information using electronic media, computers (email & instant messages), or cell phones (text messaging & voicemail). It may include writing comments about a person on a website, via instant messaging, or through text messaging, posting pictures or videos of others without their permission, or tormenting, threatening, taunting, degrading, targeting, harassing, or humiliating a student or staff member using the Internet, interactive and digital technologies, or mobile phones, or inviting other to join in these acts.

Examples of sexual harassment:

7. **Physical assault**, including rape, or any coerced sexual relation.
8. **Pressure exerted on either an adult or a student for sexual activity** or for a relationship that takes on a sexual or romantic coloring which exceeds the limit of a friendly relationship; any demeaning or repeated unwanted sexual proposition, unwelcome touching, leering at or ogling a person's body.
9. **Sexually explicit or suggestive remarks** about a person's physical attributes, sexual orientation, clothing, or behavior, sexually stereotyped or sexually charge insults, humor, or verbal abuse, and inappropriate personal questions.

9g. Senior Pranks or Ditch Days

Senior pranks or ditch days are not condoned by the LCA administration. Students who enter the LCA school building without permission commit a criminal act and the police will be contacted. Senior ditch days will not be excused, even with a parent phone call. The absence will be

recorded as truancy and a loss of opportunity to make any schoolwork missed.

10a. Academic Honesty Policy

Cheating is incompatible with the mission and philosophy of the Lighthouse Christian Academy. Cheating in any form is an unacceptable behavior. A student who uses the work of another person without acknowledging it through proper citation is acting in a dishonest and deceptive manner. They compromise their integrity and diminish what the LCA represents.

Cheating includes:

1. Copying Homework
2. Copying test or quiz answers, assignments, essays or projects.
3. Using another's words or ideas without providing appropriate citations.
4. Students providing inaccurate grade information to the teacher in an attempt to help a classmate or themselves.
5. Copying material from the internet or any other source without providing proper citations.

Neither pressure for good grades, inadequate time to complete an assignment, inadequate supervision during an examination, ignorance, nor unrealistic parental expectations justifies cheating. Cheating places the value of grades over learning.

Cheating will result in an automatic suspension from the Lighthouse Christian Academy, and possible expulsion if premeditation is involved.

Students cannot tolerate cheating by their classmates; they *must* privately report it to the teacher or another school authority. Students who choose to empower their classmates by ignoring the problem or assisting their deceptive activity by not getting involved will be disciplined for their passive involvement.

Plagiarism

Plagiarism is the presentation of the ideas or words of another as one's own. To copy from another or use his ideas without proper acknowledgement is stealing.

The written and oral material you present should be your own original and individual work. One of the purposes of education is to help you develop creativity and communication skills.

Specific types of Plagiarism:

1. Copying a direct quotation of the work of another without giving credit to the author.
2. Copying another's words with rephrasing or substitution's without giving credit to the author. Taking the ideas of another and presenting them as your own original idea.
3. The correct forms of acknowledgement are part of the English Department curriculum. If you have a question, ask your English teacher or check your English textbook.

Consequences of Plagiarism:

The administration will deal with plagiarism on an individual basis. The consequences may range from a failing mark on the assignment to expulsion.

10b. Academic Probation

A Lighthouse student is placed on Academic Probation if one or more of the following is applicable during a semester grading period:

A student accumulates two “D’s” OR one “F”

A semester GPA below 2.0

Parents will not necessarily receive a letter informing them of their child’s probationary status. It is the responsibility of the parent to follow academic progress or regress and to recognize the academic needs of their child. If any of the above conditions are not remedied by the next grading period, the student will risk academic expulsion. The principal will make all final decisions, taking into consideration all available information.

Students on a financial scholarship jeopardize their scholarship when placed on academic probation. If a scholarship student is notified of their academic probation, they have six weeks to improve their grades before losing their scholarship.

11b. Course Prerequisites

Algebra 1: At least a “C” in 8th grade math, Pre-Algebra or Remedial Math.

Algebra 2: At least a “C” in Algebra I.

Chemistry: At least a “C” in Algebra I.

Advanced Math: At least a “C” in Algebra I, Geometry and Algebra II

Spanish 2: At least a “C” in Spanish I

Spanish 3: At least a “C” in Spanish II

The competition for admission into any four-year college or university program is growing. Students who merely satisfy the basic minimum requirements will likely have their college application rejected. Therefore, the LCA encourages parents/guardians support their child’s teachers and encourage their child to work diligently at their academic pursuits according to Colossians 3:23. The LCA strives sincerely for academic excellence as well as excellence in Christian character.

11c. Requirements for Seniors

Seniors must have a minimum of 5 semester classes or 30 units each semester according to Education Code 46145, which reads: “Pupils in grade 12 shall be enrolled in at least 5 courses each semester.” The LCA enforces this code strictly; however, a senior may be enrolled in an ROP course or a community college course as their 5th class. Principal approval and written parental consent is necessary in all cases. Furthermore, seniors must have at least 200.0 credits or be short no more than 20.0 credits in required courses in order to participate in the graduation ceremony. All graduation requirements must be documented and completed in order for a graduate to receive a diploma.

11d. Standardized Testing

All students are required to take a standardized test once a year to help measure academic progress. Students in each grade level must complete the following standardized tests:

- 9th: PSAT
- 10th: PSAT
- 11th: PSAT
- 12th: SAT or ACT*

*The PSAT is given on-site once a year. The SAT or ACT must be taken off-site at the student's expense. Seniors will receive a provisional diploma until their official scores have been received.

11e. Homework

Homework is an essential part of the educational process, and LCA students will be expected to complete frequent homework assignments. The LCA believes that homework should be given in moderation, to promote excellence, and does not give homework merely as busy work. Homework is given as reinforcement of and for the purpose of practicing the various skills learned in school. Students are given individual homework assignments based on their academic needs. It has been found that the most successful students usually have active parental participation in homework and schoolwork. By doing academic work at home, the information becomes linked with both home and school, and this strengthens the importance of learning for the student. Generally, if the parent has an apathetic attitude toward homework, the student does also, and this attitude is carried over to the classroom. Learning requires hard work and perseverance. When a student feels that he/she can master a skill, he/she then feels motivated to tackle the next difficult step. Homework that is given specifically to meet the needs of the student helps to ensure success.

A student's home study environment is a very important factor in a productive homework time. The student's study area should be free from T.V., music and other distractions.

11f. Grading System

“A” Excellent (90-100% of the available points in the course)

The quality of work consistently demonstrates a superior comprehension of course content and far exceeds performance standards. The work exhibits exemplary creativity, imagination, initiative and application of material.

“B” Above Average (80-89% of the available points in the course)

The quality of work consistently demonstrates a superior comprehension of course content and exceeds performance standards. The work exhibits noteworthy creativity, imagination, initiative and application of material.

“C” Average (70-79% of the available points in the course)

The quality of work demonstrates an adequate comprehension of the course content and meets performance standards. The work exhibits satisfactory initiative and application of the material.

“D” Below Average (60-69% of the available points in the course)

The quality of the work demonstrates an unsatisfactory comprehension of course content and performance standards. The works exhibits insufficient initiative or application of the material. If a student receives a semester mark of a “D” in any course required for graduation, he/she must retake the course for the semester in which they earned the unsatisfactory grade.

“F” Failing (Below 60% of the available points in the course)

The quality of work demonstrates an inadequate comprehension of course content and does not meet performance standards. An “F” in any semester of any course must be retaken.

Extra credit might be available in a class, but only offered after all assignments have been turned in. The extra credit will be academic in nature.

11g. Grade Reports

The Lighthouse Christian Academy grade point average (GPA) is based on the achievement of the student in the classroom. Grade reports are issued to students and parents at the completion of each semester. Progress reports are available by checking the online grade reporting system. Semester grades are the only grades reported on the permanent record.

It is the responsibility of the parent to follow the academic progress of their child and parents are strongly encouraged to monitor their students progress on a frequent basis. Teachers are not required, nor should they be expected, to inform parents of missing homework assignments or poor scores on tests.

Calculation of the grade point average is based on all graded courses. Each grade is given a specific number of points described below:

B+	3.3 points
B	3.0 points
B-	2.7 points
C+	2.3 points
C	2.0 points
C-	1.7 points
D+	1.3 points
D	1.0 points
D-	0.7 points
F	0.0 points

In order to maintain eligibility for varsity athletic competition, the California Interscholastic Federation Southern Section (CIF-SS) requires student athletes to maintain a GPA of 2.0 or better for the previous grading period. The day for establishing eligibility for the next quarterly period is the day following the official issuance of report cards. All other criteria for establishing academic eligibility will be found in the CIF-SS Blue Book.

Weekly (even daily) progress reports can be seen online at Gradelink. (See Section 5c). Written or email progress reports may be issued at any time during the quarter whenever the teacher wishes to commend a student for his/her positive achievement and/or to recommend methods to help the student improve in areas where they are having problems. Report cards are issued every semester and are based on the student's academic performance during the previous grading period.

Christian Character grades are given each semester. They are an average grade from the core teachers of the student over the course. Teachers give grades based on perceived Christian character as well as academic behaviors including class participation and striving for academic excellence. These grades are meant for personal enrichment only and are not calculated into the semester GPA.

11h. Repeating Classes

With the approval of the principal, a student may repeat a course in order to raise a failing grade. The LCA will keep a record of both grades, and both grades will be recorded on the student's final transcript.

Incomplete grades are issued for students who fail to complete a required element of a class whether it be a test, project or class hours. Correcting an Incomplete grade is not retaking a class, so students who complete these required element will receive a calculated grade that will be recorded once on their final transcript. Students who fail to correct their Incomplete grade by the end of the following summer school period will receive a final failing grade and the class will have to be retaken.

11i. Summer School

Any course taken during the summer or after school during the regular year must be approved by the principal for the course to be applied to the Lighthouse Christian Academy transcript. Permission must also be obtained by the regular teacher of the class. Any course that was initially taken and failed at the LCA must be retaken at the LCA. If a student wishes to enroll in a class not available to them at the LCA, they may only do so at one of the local community colleges.

All the LCA rules and regulations will be enforced during the summer session, including regulations for dress and appearance. Additional tuition fee applies. There are no scholarships available for summer school tuition fees.

11j. Semester / Final Exams

At the end of each semester, comprehensive semester exams are administered in each subject. Only students who have a note from a physician will be excused from school during scheduled semester exams. The weight of the various components of the semester grade are determined by individual teachers, but semester exams shall not exceed one third of the semester grade. A Semester Exam schedule will be followed during this testing with 120 minutes allotted for each test. On these days school will typically follow a half-day schedule and end at 1:30pm.

11k. Honor Roll/Principal's List

Each semester, students who excel in classroom performance are honored with placement on the LCA Honor Roll as follows:

Honor Roll – 3.0 to 3.49 GPA on semester report card

High Honor Roll – 3.5 or higher GPA on semester report card.

Principal's List – 4.0 or higher GPA on semester report card.

11l. Valedictorian and Salutatorian

Academic excellence is important at the Lighthouse Christian Academy. We want to celebrate all students who achieve excellence based upon the high standards that the school, along with our Board of Education and the State of California has set.

For the graduating class, Valedictorian and Salutatorian status is determined by the students' academic GPA. The single individual with the highest GPA will automatically become the Valedictorian, and the runner-up, the Salutatorian. High school students must have attended four years at LCA or other accredited high school (minimum 2 years at LCA) to be eligible for valedictorian or salutatorian.

11m. End of Year Awards

At the conclusion of the school year three awards will be given each recognizing a different aspect of educational excellence. These emphases will be academic excellence, excellence in Christian character and service, and excellence in improvement. All students are eligible for these awards though preference may be given to seniors.

11n. Concurrent Enrollment

A student in grades 9-12 may apply to Santa Monica or West LA Colleges to take an enrichment or advanced course concurrently with LCA enrollment.

11o. Special Needs

Students determined to need special accommodations as listed in an active I.E.P. or as a result of a plan resulting from the school's Resource Department may have differential graduation standards as agreed to by the Head of School and parents.

ATHLETICS

12a. Athletic Programs

The purpose of the Lighthouse athletics programs is to instill a physical discipline and determination in the students, as well as instructing them in the importance of teamwork so that they might be more adept at fulfilling the purposes of God amidst the trials of life.

The LCA competes against the private schools of the Harbor League and against other private schools under the banner and guidelines of the CIF-SS. The coaches of the respective sports and the athletic director are the primary sources of information concerning practice and game scheduling.

Most of the sports at the Lighthouse offer interscholastic competition at the Varsity level. The Head Coach of each sport determines the individual team rosters and depth charts.

Any student receiving a G.P.A. below 2.0 for the quarter will be declared ineligible for the following quarter.

Athletes must be in attendance for at least two class periods in order to participate in that day's game.

At present, students interested in participating in Varsity Level sports must pay a sports fee ranging from \$150-\$300 per sport. This money pays for travel expenses and facility and equipment needs for the athletes.

Students on a financial scholarship may be required to participate in certain sports as a way to contribute to the sports that we can participate in as a school.

12b. Weight Room

This facility is for the use of student athletes that represent the Lighthouse Saints sports program. Students involved in athletics independent of the LCA will not have access to the work out facility. The weight room is *not* co-ed. Male and female athletes must work out separately during designated times.

The training regimens for each specific sport are designed to enhance the ability of the athletes; they are not designed for the purpose of body sculpting.

Student use of the weight room is predicated on their willingness to follow said policies and maintain its upkeep.

12c. Fan Code of Conduct

Enjoy the Game. Respect Other Fans.

Lighthouse Christian Academy is committed to creating a safe, comfortable and enjoyable experience for all fans, both in the stadium and in the parking lot. We want all fans attending our games to enjoy the experience in a responsible fashion.

When attending a game, you are required to refrain from the following behaviors:

- Behavior that is unruly, disruptive or illegal in nature
- Intoxication or other signs of alcohol impairment that results in irresponsible behavior
- Foul or abusive language or obscene gestures
- Interference with the progress of the game (including throwing objects onto the field)
- Signage that is offensive, in poor taste, or does not support sportsmanship
- Failing to follow instructions of stadium personnel
- Verbal or physical harassment of opposing team fans or referees
- No smoking

DISCIPLINE

13a. Minor Infractions/Chain of Consequences

The Lighthouse Christian Academy strives to provide a loving and excellent Christ-based learning environment. This environment can be described as one that is polite, humble, and selfless. LCA students are expected to show a loving and excellent attitude toward their teachers, school work, peers, and school. Students who violate the prescribed code of conduct will receive discipline.

1. Violating students will have to attend the enrichment period (1:35-2:20pm) the day of the offense to do standards. Should the student have an elective class during that period on that day, the student can arrange to do the standards on a non-elective day or during the lunch period. Parents will be notified of their child's behavior and enrichment requirement. Students that fail to show up for enrichment will have double the discipline the next day. Failure to attend the enrichments can result in a suspension.

2. Violating students can be placed in Individualized Study Program separate from the main classroom until they demonstrate repentance and a willingness to participate appropriately. They will be given a discipline paper to complete and parents will be notified of their child's behavior.

3. Over time the student's ISP will be evaluated. If students show a positive response they will be allowed to return to the main classroom. If students fail to show a positive response the ISP may be further adjusted. Further adjustment of an ISP may include a student being placed on behavioral probation or working from home and only allowed to come on campus or participate in classes and school functions in a limited manner.

4. Continual failure to respond to an ISP will result in a student's expulsion from LCA.

13b. Major Infractions

Major infractions may result in immediate suspension and the placement of the student on behavioral probation or expulsion from school depending on the infraction and its severity. Students given a suspension may also be placed on an ISP until the necessary improvements are made.

The following infractions are grounds for immediate **suspension**:

Gossip; Smoking; kissing; dating; hosting an unsupervised co-ed party; possession of any soft-core pornographic material; lying or forgery; getting a tattoo; extra-body piercings; physically aggressive behavior or fighting, threatening force or violence toward other students or staff; pranks; and disrespectful/ belligerent or defiant behavior.

The following infractions will result in the **expulsion** of a student:

Theft; the possession, use, or sale of narcotics or alcohol; tobacco products; the possession or sale of fireworks or any weapon on campus; membership in a gang or association with gang activities; regularly failing to pass classes; chronic lying or deceit; habitual or repeated violation of school rules; hazing; chronic attitude of rebellion; sexual immorality; possession of hardcore pornography; **any major offense, behavior or attitude considered detrimental to the mission of the Lighthouse Christian Academy and its ability to train students to serve the Lord.**

****The paramount factors in deliberating student discipline is the student's response, namely do they act remorsefully, responsibly, and honestly towards their infraction.**

13c. Behavioral Probation

Students given an ISP or suspension will be considered on behavioral probation. Students on behavioral probation may be limited in their participation in school athletics, trips, and activities and can be immediately expelled if further violations continue. In some cases of behavioral probation, students will be allowed to remain enrolled in the school, but required to do their work from home.

13d. Dating v. Courting

At the LCA dating is prohibited as a behavior that is ultimately selfish and destructive. Courting, however, is permitted under careful guidelines. Courting involves the following elements: the permission of both party's parents/guardians, the setting of physical boundaries and prohibitions until marriage, accountability by remaining part of a larger group during outings and avoiding compromising situations; and most importantly making stated and ultimate goal of the relationship to seek out another's suitability for marriage. The purpose of this rule (prohibition of dating) is to protect all the students from broken relationships, drama, and distractions.

13e. Off-Campus Incidents

The Lighthouse Christian Academy does not wish to supervise the lives of its students away from school. Nevertheless, ungodly behavior outside of the school clearly demonstrates ungodly character in a student, and needs to be disciplined. Off-campus incidents can directly affect other students or members of the administration, faculty or staff, or damage the reputation of the school. Involvement in this type of behavior will not be tolerated. Any student that behaves off-campus in a manner disapproved of by the Academy as set forth in the previously stated rules will be disciplined accordingly. This includes all conduct via electronic communication like Facebook, text messaging and e-mail.

13f. Cell Phones & Electronic Devices

Cell phones are prohibited during class unless expressly directed otherwise by the teacher. **Cells found in use during unauthorized periods will be confiscated by the teacher held in the office for 5 school days and until \$10.00 is paid.** Cell phones are allowed outside of class before and after school and during lunch and breaks unless used in an inappropriate manner or in conjunction with inappropriate media.

The use of electronic devices such as iPods, Mp3 players, or handheld game systems of any kind used in conjunction with inappropriate media is prohibited on campus at all times including before or after school. The use of headphones is prohibited at all times before or after school. **Electronic items used inappropriately, including headphones, will be confiscated and held for 5 school days and until \$10.00 is paid.**

14. Student Safety

Lighthouse Christian Academy is an open campus. Students have the opportunity to leave campus during breaks and the lunch period.

In times of emergency the LCA Administrator has the authority to do what is necessary to protect the safety of students and staff. The Administrator will assign staff to perform required duties at assigned stations. The staff and students shall be constantly aware of the various alarms and what they mean as well as the general procedures to be followed in emergency situations. All teachers and staff are trained in CPR and First Aid.

Students who are ill or are in need of first aid must report to the school office. When an injury occurs at school, basic first-aid treatment will be given if the injury is minor. If the injury is serious or if the ill student needs to go home, parents will be contacted immediately. If the parent is unavailable, staff will contact persons listed on the student's emergency form to pick up the student from school. It is critical that parents keep the school office emergency records up to date so that students can be promptly treated in the event of an accident or serious illness. Students must check in with the school office prior to leaving campus due to injury or illness.

In case of an emergency, the emergency contact person(s) will be notified. Accidents requiring immediate medical care will be handled by the 911 Emergency Services.

The Lighthouse Christian Academy does not provide medical insurance coverage for school accidents. **Parent(s) and/or legal guardian(s) are fully responsible for medical bills if their child is hurt during school activities.**

Students needing medication (prescription or over-the-counter) during school hours must have a completed "**Medical Authorization Form**" signed by the parent or guardian on file with the school office. Medication must be in a labeled prescription bottle or original packaging complete with dosage instructions for the student and all medications must be locked in the school office. The school office staff will administer the medication or assist the student with administration if they are able to take the medication on their own. Teaching staff are instructed not to administer medication at school.

15. Earthquake Procedures

We, as Californians, are aware of the ever-present possibility of an earthquake occurring and creating damage and dangerous conditions. The safety and welfare of our students is of the utmost concern to us. Public safety officials have stated that the school environment provides the safest possible protection during a time of general emergency. In line with this, we have devised specific procedures to follow in the event of a severe earthquake (7.0 or larger) or other life-threatening catastrophe.

Where to locate your child: In the event of a severe earthquake during school hours, students will remain at the school until parents or legal guardians or their authorized representatives have been successfully contacted.

Each student is to provide their own earthquake kit each year, which is to include the following:

- 1-2 small water bottles
- protein snack
- granola bar
- small flashlight
- emergency whistle
- small first aid kit
- emergency blanket
- hard candies
- hand sanitizer
- wipes

You may also purchase a pre-made kit online.

TUITION AND FEES

16a. Schedule of Tuition and Fees

REGISTRATION FEE (non-refundable, for first time enrolling students only)

\$250 (payable upon registration)

TUITION

Tuition is \$7,200. For convenience, LCA can charge \$600 per month for 12 months (Aug-July). Tuition is charged on the 15th of each month.

Students with outstanding balances will not receive report cards or have transcripts released.

LCA families are strongly encouraged to carefully budget for the prompt payment of their school account. The school's operation and ministry depends on a consistent income from tuition. When a child attends any portion of the month an entire month's tuition must be paid.

Unpaid tuition and fees that go past 50 days will cause suspension of the account, at which time the student will not be allowed to attend LCA until the account is brought current. It is the parent's responsibility to notify the LCA business office of any extenuating hardships before the account goes into suspension or prior to late fees being assessed.

There are no refunds if a student is withdrawn from LCA.

16b. Scholarship Program

The Lighthouse Christian Academy does not offer financial aid (giving money to families) to its students. However, each year some students will have the opportunity to participate in a pledge program for reduced tuition. The reduced tuition amount is determined by the principal. Interested families are required to complete an application. Students in the pledge program may be asked to help raise additional offsetting funds through various means including housing international students, participating in school and church fundraisers, joining a school custodial team and seeking personal sponsors.

Students interested in the scholarship program should schedule a meeting with Principal and complete the Financial Information Form upon registration.

The pledge program is a privilege and pledge students must demonstrate an excellent effort in behavior and academics to remain in the program. Students that fall below a 2.0 GPA are subject to have their scholarship removed.

17. School Library

At present, the Lighthouse Christian Academy does not have an in-house library. Each student has access to the local public library as well as supervised use of the internet to collect necessary materials.

The Santa Monica Public Library is located approximately two miles from the school, at 601 Santa Monica Blvd., and is easily accessible by the local Santa Monica Big Blue Bus, Line 1. The library is open Monday through Thursday from 10am to 9pm, Friday and Saturday from 10 am to 5:30 pm, and Sunday from 1 pm to 5 pm.

There are a variety of resources available to students through the Santa Monica Public Library, including:

- Access to books and audiovisual materials
- Access to computers with word processing and internet capabilities
- Access to a wide variety of online databases, including eLibrary and the Gale Student Resource Center
- Help from a Children's Librarian – in person, over the phone (310.458.8621) or via e-mail

At the beginning of each year, all students who are not acquainted with the library or do not have library cards will be taken on a field trip to the library, at which time they will be able to apply for library cards and will be given a library tour by a Santa Monica Public Library Children's Librarian.

18. Counseling Services

The purpose of counseling services at Lighthouse Christian Academy is to promote positive interpersonal relationships, promote spiritual growth, help each student grow to their full potential, as well as to provide information and instruction. We will always endeavor to counsel in a spirit of humility using scriptural guidelines and sound principles of human behavior.

Services will be provided in the following areas:

- A. **Spiritual** (relationship to God, character development).
- B. **Educational** (academics, scheduling, information regarding further education).
- C. **Vocational** (information, testing, and direction for life vocation).

Because Lighthouse Christian Academy views the family unit as the most important human relationship, it will involve members of the student's family in any counseling where counselors feel it would be helpful.
